### 1 Information on the eCI@ss price list

All prices refer to releases in **all available languages** and **all export formats** (BASIC and ADVANCED (since eCI@ss 7.0), csv and XML (since eCI@ss 7.0)). To purchase an eCI@ss license – independent of the license type – a registration and order via the eCI@ss DownloadPortal are necessary. A license is valid for the registered company and all its >50% subsidiary companies. The calculation basis is the number of employees including all >50% subsidiaries.

#### 1.1 Concordance license

Contains **all already published** as well as **all releases to be published during the concordance runtime in all languages** as well as **all available eCI@ss mapping tables**. The minimum runtime is three years and will be automatically extended by one year, if it is not canceled three months before the end of the contract.

In the first year a fee of 20% is charged in addition to the annual amount.

#### 1.2 Single license

Contains **one release** (e. g. eCI@ss 8.0) in **all languages and export formats**.

#### 1.3 Mapping tables

Contain the available information to map from a source release (e. g. eCI@ss 7.1) to a target release (e. g. eCI@ss 8.0), respectively to make an upgrade. Apart from the mapping tables, both the source release and the target release are needed for the upgrade.

### 2 Membership fee
