General information on the eCl@ss price list

1.0 Obtaining licenses

All prices refer to releases **in all available languages** and **all export formats** (BASIC and ADVANCED (since eCl@ss 7.0), csv and XML (since eCl@ss 7.0)). All available releases are listed in the [eCl@ss Wiki](http://wiki.eclass.eu/wiki/Category:Products#Release_Sizes) (http://wiki.eclass.eu/wiki/Category:Products#Release_Sizes).

1.1 Single license

Contains **one release** (e. g. eCl@ss 11.0) **in all languages and export formats**.

1.2 Concordance license

Contains **all already published** as well as **all releases to be published during the concordance runtime in all languages** as well as **all available eCl@ss update files**. The minimum runtime is three years and will be automatically extended by one year, if it is not canceled three months before the end of the contract.

In the first year a fee of 20% is charged in addition to the annual amount.

2.0 Update files (former “Mapping tables”)

Contain the available information to update from a source release (e. g. eCl@ss 10.1) to a target release (e. g. eCl@ss 11.0). Apart from the update files, both the source release and the target release are needed for the update.

3.0 Membership

Supporting members receive **50% discount on all products**.

All Ordinary eCl@ss members receive **all releases in all languages** as well as **all available update files** within the framework of their membership free of charge.

For tax recognized **non-profit organizations**, we offer a discount of 50% on all membership fees.

4.0 Pay per IRDI (starting in 2020)

You can obtain individual IRDIs through our web service. The price per IRDI access is 0.05 € (net). License costs are calculated per IRDI at each access.

Since structural elements have the same IRDI across all languages, the fee for accessing an IRDI in several languages is calculated only once per access.

For members and concordance license-holders, this service will be free of charge.
